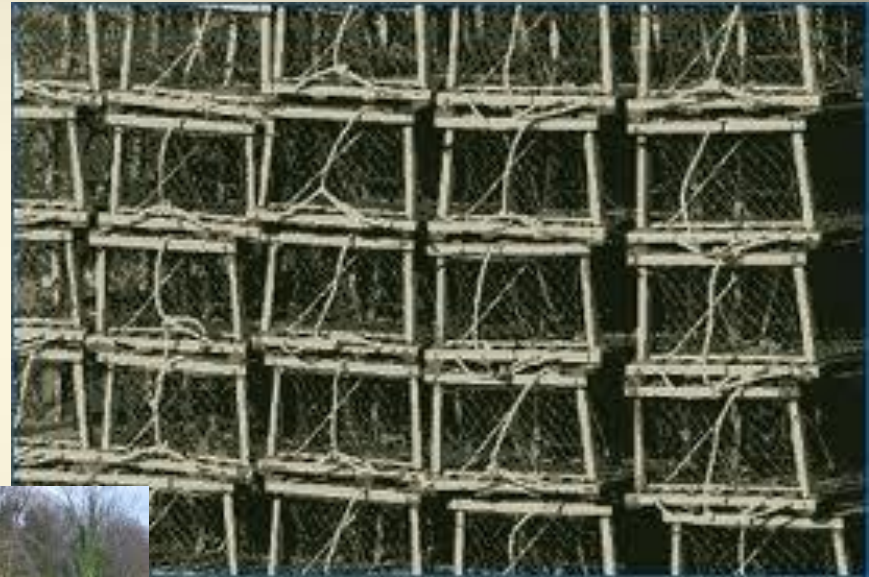

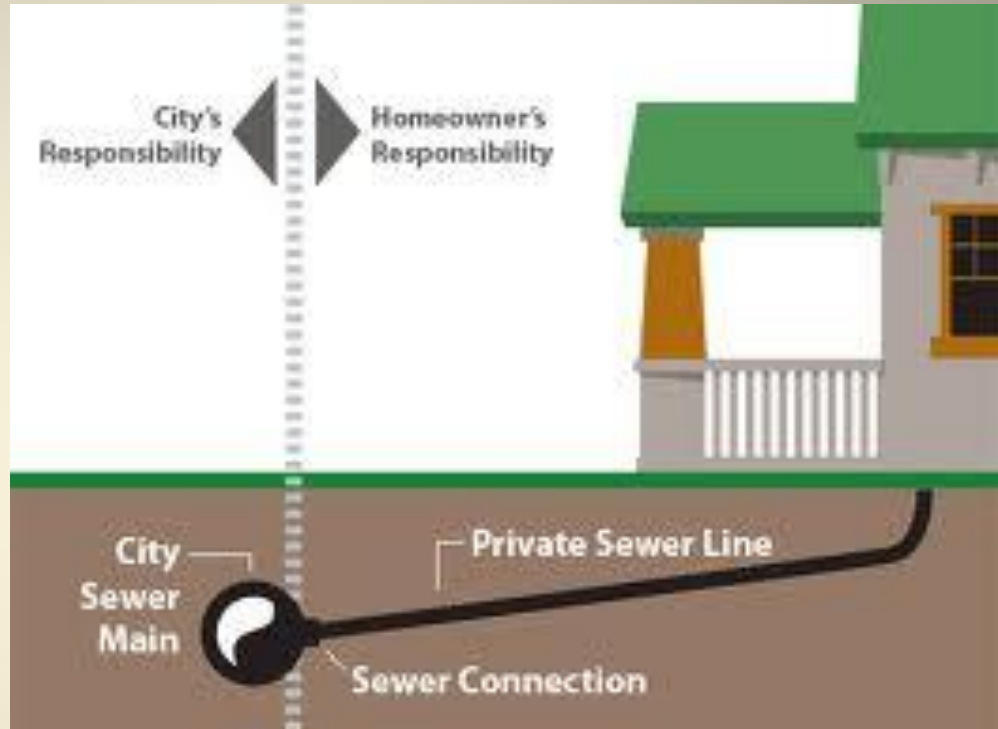

SEWER CHARGE NOTICE, LIEN CLAIM AND DEMAND
38 M.R.S.A. § 1208

IMPORTANT: DO NOT DISREGARD THIS NOTICE. YOU WILL LOSE YOUR PROPERTY UNLESS THE SEWER CHARGES, INTEREST AND COSTS ARE PAID.

To: Arnold Douglas

You are hereby notified that sewer rates, tolls, rents or other charges ("Sewer charges") of \$ 123.45 assessed to the real estate described below and committed to me as Treasurer on January 15, 2011 less payment of \$ 0.00, remains unpaid. The subject real estate is described as follows:

Sewer charges were assessed to Arnold Douglas as owner or occupant of the property.

A LIEN IS HEREBY CLAIMED on the above-described real estate to secure payment of the sewer charges. Payment of said sewer charges, together with interest of \$ 2.25 (which has been added to and become part of said tax), a fee of \$3.00 for making this demand, and the certified mail fees of \$ 5.54, **FOR A TOTAL SUM OF \$ 134.24 IS HEREBY DEMANDED OF YOU WITHIN 30 DAYS FROM THE DATE OF SERVICE OR MAILING OF THIS NOTICE.**

Note: If your personal liability for this sewer charge has been discharged in a bankruptcy proceeding, then any demand for payment set forth above is provided to you only to permit the municipality to retain its lien on your property and not as an attempt to have you pay the discharged debt.

In order for an installment payment plan to be manageable for you and scheduled in a way that will allow your balance to be paid in full before a sewer lien forecloses and passes title to your property to the town, you need to make these installment payment arrangements with the municipality as soon as possible.
